The survey on carriage of goods and passengers through ports established with the legal acts of the EU is performed based on a consistent methodology and it allows to compare the changes in the carriage of goods and passengers in different countries.

Pursuant to the directive 2009/42/EC of the European Parliament and of the Council of 6 May 2009, Statistics Estonia collects data from the largest statistical ports (main ports) of Estonia. Pursuant to the directive, the survey investigates those ports which process over one million tonnes of goods and/or is visited over 200,000 passengers in a year. A statistical port consists of one or several ports which are capable of registering the movement of vessels and cargo, and which is generally controlled by one port authority.

The data will be published in the statistical database https://andmed.stat.ee/en/stat in section Economy / Transport / Water transport. The dates about the publication of new statistics can be found in the release calendar, which is available for the consumers on the website of Statistics Estonia.

Carriage of goods are the goods transported on commercial sea journeys. Bunker fuel for ships, ship's stores of maintenance equipment, food and supplies are excluded, since these are related to the operation of vessels.

Weight of goods includes the weight of the package but not the tare weight of containers and roll-on/roll-of units.

The loading and unloading of goods is calculated together with transit goods.

Number of outward/inward passengers is number of passengers who start/finish the voyage in port and it does not include crew members.

eSTAT (https://estat.stat.ee/) is for data submission.

Please make sure that you enter data in the correct cell. If you enter alphabetical characters in a number field, a corresponding error message is displayed. In the case of some fields, logic (arithmetic) checks have been applied to prevent data entry mistakes. If there is a conflict in the entered data or they conflict with prefilled data, an error message appears when the table is checked. In the case of errors, review the data carefully and make corrections.

After correcting the data, save changes and check the questionnaire again. If there are no more mistakes, confirm and submit the data by clicking "Confirm" on the last page of the questionnaire.
