0. Information for the respondent

The statistics based on the purchase of milk questionnaire provide both purchasers and agricultural producers with up- to-date information about purchase price levels.
The data with the questionnaire are used by the Ministry of Regional Affairs and Agriculture to monitor the milk and milk products market and to implement market organisation measures if required.
Based on the purchase prices of milk, Statistics Estonia calculates value of milk production in Estonia, which is used to assess the income of the agricultural sector nationally and internationally.
The income indicators of the agricultural sector are input to:
the Estonian Agriculture and Fisheries Strategy 2030 (AFS 2030),
the Common Agricultural Policy Strategic Plan,
sustainable development indicators, and
GDP calculations.
The agricultural sector relies on income data in relevant negotiations in Estonia and in the European Unio.
Data purchase of milk are collected monthly from all milk purchasers registered with ARIB and from milk processing enterprises approved by the Agriculture and Food Board and producing milk products.
The questionnaire has changed compared to the 2024 version. Estimates of purchased milk by grade are asked only in December as annual quantity estimates.
The row "Purchased cows' milk and cream" in Table 1 is prefilled with data from ARIB on day 17 of the month.
Please double-check the prefilled fields and correct where necessary.
If you revise/correct prefilled data from ARIB, you should also notify ARIB of the revisions.
The purchase price of milk must include the entire purchase price, including contractual additions or deductions.
If some of the additions or deductions are made retroactively for previous months
the data on previous months are not corrected and the retroactively made additions or deductions are reported in the month of actual payment.
The error message "Warning" indicates possible errors. Please make sure that you have entered the correct data, then click "Accept warnings" and confirm the questionnaire.
In the absence of values, you do not have to enter 0 (zero) in the fields.
